Amounts are based on the following criteria:

- 1 FAFSA  
Completion of the FAFSA process (regardless of eligibility)
  - Students with a completed FAFSA will receive the largest award amount, but **students with incomplete FAFSA or no FAFSA will still receive money**
- 2 EFC  
Estimated Family Contribution (EFC; based on FAFSA)
  - Students who enroll full-time and have a completed FAFSA will receive \$1500 **regardless of EFC**
  - Students enrolled less than full-time will receive amounts based on EFC
- 3 Credits  
Number of credits enrolled
  - Award amounts are determine based on full-time,  $\frac{3}{4}$  time,  $\frac{1}{2}$  time, and less than  $\frac{1}{2}$  time. **The more credits you enroll in, the more money you receive.**
