### PURPOSE

The purpose is to outline the procedure Arizona Western College's (AWC) Information Technology Services & Support (ITSS) to establish terms of Service for free public wireless internet access to visitors of Arizona Western College (AWC). You may use the network only if you agree to the following terms of service each time you access the network.

### SCOPE

This procedure applies to all users of AWC technology assets including employees, students, visitors and partners.

### PROCEDURE

1. Access to the network
  - 1.1 The network is a free public service provided by AWC.
  - 1.2 Your access to the network is completely at the discretion of AWC. Access to the network may be blocked, suspended, or terminated at any time for several reasons including, but not limited to, violation of this Agreement, actions that may lead to liability for AWC, disruption of access to other Users or networks, or violation of applicable laws or regulations.
  - 1.3 AWC reserves the right to filter websites deemed to be inappropriate or potentially harmful.
  - 1.4 AWC may revise the Terms of Service ("TOS") at any time. You must accept this Agreement each time you use the network, and it is your responsibility to review it for any changes each time.
    - i This is an open wireless network.
    - ii No network communication is 100% secure.
    - iii Please remember: NO network communication should be considered private or protected. All communication over this network is subject to monitoring. AWC reserves the right to reduce throughput or access as needed.
2. Acceptable Use of the Service
  - 2.1 Your use of the network and any activities conducted online through the Service shall not violate any applicable law or regulation or the rights of AWC, or any third party. AWC cannot accept any responsibility for any injury or loss that results from inaccurate, unsuitable, offensive, or illegal Internet communications.
