PREREQUISITE: None

COURSE DESCRIPTION

Instruction is individualized. Focus will be geared towards the components of fitness in achieving a healthy life style. Class fee will be charged. NC/CR

1. COURSE GOAL

Fitness Training has become one of the more popular training methods in our society. This course provides a wide range of knowledge about proper conditioning techniques of the body.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 utilize weight and resistance training equipment safely and effectively.
- 2.2 demonstrate proper training techniques.
- 2.3 identify basic body anatomy and demonstrate proper body mechanics.
- 2.4 develop a safe and effective personal exercise program.

3. METHODS OF INSTRUCTION

4. LEARNING ACTIVITIES

- 4.1 Student participation

5. EVALUATION

- 5.1 Student's accomplishments will be evaluated by competency-based skills and body composition measurements
- 5.2 Student must participate in a minimum of three hours of exercise per week. Within those three hours, one hour must be with the instructor

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
