# ARIZONA WESTERN COLLEGE SYLLABUS

PER 106 WALKING/JOGGING Credit Hours: 1 Lec <u>.5</u> Lab 1

PREREQUISITE: None

#### **COURSE DESCRIPTION**

Individually paced walking/jogging using effective techniques. Includes cardiovascular work out within a target heart rate zone to promote positive health fitness and confidence. CR/NC

## 1. COURSE GOAL

This course prepares learners to develop a level of cardiovascular fitness conducive to a healthy lifestyle through walking or jogging.

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 evaluate his or her fitness level.
- 2.2 complete an activity log including dates and time of walking or jogging.
- 2.3 list safety techniques.
- 2.4 complete a daily log on heart rate recovery time.

## 6. STUDENT RESPONSIBILITIES
