PER 116 SPEED AND AGILITY TRAINING Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>2</u>

PREREQUISITE: None

COREQUISITE: Collegiate Athlete Member

COURSE DESCRIPTION

This class will provide instruction and practice in the skills and understanding of conditioning and agility training for the college athlete in preparation for competition.

1. <u>COURSE GOAL</u>

To provide the athlete with the knowledge and practice needed to implement conditioning and agility training as part of a fitness and performance routine. Student athletes will develop skills to apply their conditioning to enhance their sport performance in competition.

6. STUDENT RESPONSIBILITIES
