### **COURSE DESCRIPTION**

Refining the developed skills introduced in the beginning class. Includes grip, stance, swing, driving, chipping, rules, and etiquette. CR/NC

This course prepares learners to refine skills, knowledge and awareness to play golf at a level desirable to the learner.

- 2.1 demonstrate and articulate safety procedures of golf.
- demonstrate how to hit every club in a starter's set: 3, 5, 7, 9 irons and 3 wood, pitch and sand wedge, putter and driver.
- 2.3 hit the pitching and sand wedge along with the putter and driver.
- 2.4 discuss the rules and etiquette of golf.
- 2.5 practice the short game.

# 6. <u>STUDENT RESPONSIBILITIES</u>
