COURSE DESCRIPTION

Continuation of PER 147 Karate 1. Includes intermediate level Katas (combination of movements). CR/NC

1. <u>COURSE GOAL</u>

The course prepares the learner to perform Karate at the intermediate level.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 trace the development of Karate from its beginning in India to arrive in U.S.
- 2.2 demonstrate blocks, punches, kicks, and stances with precision and effectiveness.
- 2.3 demonstrate for Ippon kumite katas, two Taezu Naur, and five body forms (1 & 2 of each series).
- 2.4 demonstrate Tai kyo ku exercises one through three, and Wansu kata (three categories; mind, spirit and universe).
- 2.5 demonstrate eight self-defenses.
- 2.6 perform Kime dachi kumite for three minutes, and kata kumite for three minutes.
- 2.7 demonstrate Jiju Undo and Ukemi.

6. <u>STUDENT RESPONSIBILITIES</u>
