# ARIZONA WESTERN COLLEGE SYLLABUS

Credit Hours: 2 Lec 1 & Lab 2

PREREQUISITE: None

## **COURSE DESCRIPTION**

Introduction to various strategies and self-defense techniques applied in Hapkido system.

## 1. COURSE GOAL

Develop the basic skills necessary to utilize Hapkido self-defense techniques in confronting and defeating an attacker on real situations.

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate safely how to break fall to the front, side and rear, as well as rolls to the front and back.
- 2.2 Demonstrate effective Hapkido flow drills, also wrist and body grabs techniques as well as throwing and finishing techniques.
- 2.3 Demonstrate the proper use of hand blocking and strikes that include the fist, elbow, forearm, as well as various types of kicks, and knee strikes.
- 2.4 Demonstrate basic Hapkido throws in self-defense situations
- 2.5 Demonstrate basic ground techniques.
- 2.6 Identify and demonstrate various striking techniques to vulnerable parts of the body.

#### 3. METHODS OF INSTRUCTION

- 3.1 Lecture/Demonstration. Instructor will demonstrate self-defense techniques and require the student to practice and perform the techniques.
- 3.3 Guest lecturers/martial arts instructors.
- 3.4 Field trips/martial arts camps.

# 4. <u>LEARNING ACTIVITIES</u>

- 4.1 Demonstration of techniques by the student
- 4.2 Written/oral quizzes on vocabulary and terminology
- 4.3 Practical review of Hapkido techniques learned with partners, as well as sparing

# 6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 Classroom Assignments: Students are responsible for work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral drills and for taking all exams.
