PREREQUISITE: None

COURSE DESCRIPTION

Designed for individuals of all skill levels interested in acquiring the knowledge and techniques required for participation in recreational swimming. CR/NC

This course prepares learners to develop sufficient skill and knowledge to swim for recreation and fitness activity.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
