### ARIZONA WESTERN COLLEGE SYLLABUS

PER 161 SWIMMING: BEGINNING Credit Hours: 1 Lec .5 Lab 1

### PREREQUISITE: None

### **COURSE DESCRIPTION**

Instruction in the skills of swimming for the novice. Includes orientation to the aquatic environment, rhythmic breathing, and water entry. Also includes stroke development and deep water entry. CR/NC

#### 1. <u>COURSE GOALS</u>

This course prepares learners to develop sufficient skill and knowledge to swimming as a recreational and fitness activity.

# 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate floating on the front and on the back.
- 2.2 demonstrate submersion in three feet of water.
- 2.3 demonstrate deepwater entry and swimming 25 meters.

### 5. <u>EVALUATION</u>

# 6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
