PREREQUISITE: None

COURSE DESCRIPTION

Instruction and practice for the novice in the skills and understanding of resistance training.

1. COURSE GOAL

To provide the student with the knowledge and practice needed to implement resistance training as part of a lifelong exercise routine.

Upon satisfactory completion of this course, students will be able to:

- 2.1 apply general guidelines for safe resistance training.
- 2.2 understand the acute variables necessary for effective resistance training.
- 2.3 perform proper techniques.
- 2.4 understand muscle groups and identify several exercises for each muscle group.
- 2.5 define common terms used in resistance training.

6. <u>STUDENT RESPONSIBILITIES</u>
