PER 184 VARSITY SPORTS: WOMEN'S BASKETBALL

COREQUISITE: Team member

COURSE DESCRIPTION

Prepares individuals for competing in their first year at the collegiate level in basketball.

1. COURSE GOAL

Prepares learners to develop basic skills, knowledge and strategies to compete at the collegiate level in basketball.

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate basic skill and game knowledge of basketball.
- 2.2 improve and maintain fitness level by participation in class drills and games.
- 2.3 demonstrate basic skill progression.
- 2.4 discuss rules of basketball.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.

- 6.5 Texts and Notebooks: Students are required to obtain the class materials for the course.
- 6.6 Arizona Western College students are expected to attend every class session in which they are enrolled. To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for “No Show” reporting during the first 10 days of each semester.
- Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid.
- For online classes, *student attendance in an online class is defined as the following* (FSA Handbook, 2012, 5-90):
- Submitting an academic assignment
 - Taking an exam, an interactive tutorial or computer-assisted instruction
 - Attending a study group that is assigned by the school
 - Participating in an online discussion about academic matters
 - Initiating contact with a faculty member to ask a question about the academic subject studied in the course
