COURSE DESCRIPTION

Prepares individuals for competing in their first year at the collegiate level in softball.

1. <u>COURSE GOAL</u>

Prepares learners to develop basic skills, knowledge and strategies to compete at the collegiate level in softball.

Upon satisfactory completion of this course, students will be able to:

- 2.2 improve and maintain fitness level by participation in class drills and games.
- 2.3 demonstrate basic skill progression.
- 2.4 discuss rules of softball.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor.
