ARIZONA WESTERN COLLEGE SYLLABUS

THE 213 CREATIVE DRAMA Credit Hours: 3 Lec 3

PREREQUISITE: None

COURSE DESCRIPTION

A one semester course that introduces the student to the theory and practice of improvisation, role playing, mime, puppetry, playwriting and program development in drama and their application to elementary and secondary school levels.

1. <u>COURSE GOAL</u>

Participate in several theatrical events; perform improvisation, mime, pantomime, puppetry, juggling, and other distinct and diverse theatre skills; understand the culture and history behind these skills; effectively use these skills as teaching tools; and be able to teach these skills to others.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 participate in a variety of Improvisation warm-ups, exercises, and handles. develop mental skills in spontaneity and improvisation.
- 2.3 develop the physical skills necessary to perform Mime, Pantomime, Juggling and Puppetry.
- 2.4 discuss the history and traditions of Improvisation, Mime, Puppetry and other theatre business.
- 2.5 explore the origin and cultural use of these skills.
- 2.6 research, contrast, and evaluate methods for teaching these skills.
- evaluate the quality of such skills when performed by others.
- 2.8 demonstrate the use of these skills in public performance.
- 2.9 translate these skills to classroom use.
- 2.10 teach such skills to others.

3. METHODS OF INSTRUCTION

- 3.1 Lecture
- 3.2 Class participation in exercises and productions and skill building sessions
- 3.3 Participation in a Story Book Theatre presentation to be performed for elementary school students
- 3.4 Present a Lesson Plan and teach a skill to the class

4. LEARNING ACTIVITIES

- 4.1 Class Participation
- 4.2 Practical experience with objects, props and equipment
- 4.2 Class presentations, group projects, and Story Book Theatre productions
- 4.4 Preparation and teaching of a skill oriented lesson plan
