# ARIZONA WESTERN COLLEGE SYLLABUS

THE 222 VOICE AND DICTION

Credit Hours: 3 Lec 3

PREREQUISITE: None

## **COURSE DESCRIPTION**

This course introduces the student to study and training in basic voice production. Included will be instruction in proper breathing techniques, sound production, kinesics, general speech standards, and common voice problems. This course will promote development of naturalness and flexibility in the speaking voice.

- 1.1 Exercise and practice for improving voice and diction.
- 1.2 Understand physiological and cultural factors that lead to improper pronunciation and enunciation of words.
- 1.3 The techniques to free the voice and improve projection, resonance, and articulation.
- 1.4 To have the opportunity to apply techniques for vocal and speech improvement, based on individual need.

- 2.1 explain the importance of improving voice and diction behaviors.
- 2.2 describe the physiological factors that govern breath control and sound production.
- 2.3 describe what sound is, how it is produced, and how it travels.
- 2.4 name the physical and psychological characteristics of sound.
- 2.5 explain the interrelationship between sound and speech.
- demonstrate exercises for improving breath control and sound production.
  produce, in class, voice that is free from attributes that interfere with communication.
- 2.8 speak, in class, with sufficient vocal flexibility and variety to meet the needs of most speaking situations.
- 2.9 demonstrate understanding of the vocal variables of rate, stress, and pitch.
