COURSE DESCRIPTION

Prepares individuals for competing in their second year at the collegiate level in soccer.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.

Students who are not attending as of the 45th day of the course may be withdrawn by the instructor.
