ECE 243 EARLY CHILDHOOD DEVELOPMENT

Credit Hours: 3 Lec 3

PREREQUISITES: ECE 208 and ECE 240

## **COURSE DESCRIPTION**

Exploration of the development of young children between the ages of birth and 8 years old. The course will include 32 hours of directed observation of children birth through 8 years.

## 1. COURSE GOALS

- 1.1 Understand how heredity, culture, and environmental factors can influence development of an individual before birth and up to age 8.
- 1.2 Provide basic concepts of physical, emotional, social and intellectual development of children and how they interrelate regardless of culture.
- 1.3 Provide in-depth knowledge of developmental theories and some of the more prominent persons who have contributed to the understanding of children.
- 1.4 Promote understanding of concepts related to positive self-image and high self-esteem.
- 1.6 Familiarize the student with public policy and current issues that impact children.

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe and apply the theories of development.
- 2.2 describe the physical, motor, cognitive and social emotional developments of infants, toddlers, pre-school children and school-aged children through age 8.
- 2.3 identify the different stages of language development in children and list their characteristics.
- 2.4 articulate an understanding of growth determining influences both environmental and biological.
- 2.5 identify milestones of development of children ages infant through age 8.
- 2.6 recognize and identify general disturbances in development during the pre-natal period through age 8.
