PREREQUISITES: ECE 240 or FCS 238/PSY 238

NOTE: ECE 243 suggested corequisite for degree seekers

COURSE DESCRIPTION

Introduction to the area of early childhood special education focusing on gathering information about at-risk, delayed or disabled children.

1. COURSE GOALS

- 1.1 Gain knowledge of the child with special needs in the early childhood setting.
- 1.2 Understand how to work with families of special needs children.

2. COMPETENCIES

Upon satisfactory completion of this course, students will be able to:

- 2.1 explain the state and federal rules and regulations pertaining to early childhood special education.
- 2.2 describe developmental domains in terms of normal chronological development.
- 2.3 identify disabling conditions in terms of their characteristics.
- 2.4 explain the impact of specific disabling conditions and the young child's development, relationships, socialization and learning.
- 2.5 discuss the impact of family lifestyle and belief systems in terms of parental involvement and interaction with a child with special needs.
- 2.6 compare and contrast various delivery models.
- 2.7 describe the components of an IFSP/IEP.

6. STUDENT RESPONSIBILITIES
