COURSE DESCRIPTION

This course provides students with essential skills in data acquisition systems.

1. <u>COURSE GOAL</u>

Develop essential skills to work within multi-disciplinary electronic instrumentation data acquisition systems.

- 2.2 Construct and operate a data collection / data logging systems to gather instrumentation output data

- 2.4 Analyze and process output data of an instrumentation system
- 2.5 Prepare output data into appropriate presentation format
- 2.6 Employ electrical safety for work on electronic devices and components

6. <u>STUDENT RESPONSIBILITIES</u>
