## ECT 205 FIXTURES AND INSTALLATION

PREREQUISITES: ECT 105 and ECT 110 and ECT 115

COURSE DESCRIPTION

Complete overview of the planning and installing of electrical fixtures.

Gain knowledge of practical and theoretical training in planning and installing electrical fixtures.

- 2.6 describe the fundamentals of lighting and discuss common lamp and lighting fixture terminology.

6. STUDENT RESPONSIBILITIES

6.6 Arizona Western College students are expected to attend every class session in which they are enrolled. To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for “No Show” reporting during the first 10 days of each semester.

Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid.
