ECT 210 CONTROL CIRCUITS Credit Hours: 4 Lec 3 Lab 2

PREREQUISITES: ECT 105

COURSE DESCRIPTION

Complete overview of the principles and applications of components, control circuits, and diagrams.

Gain knowledge of practical and theoretical training in diagrams and control methods.

- 2.4 draw electrical diagrams and wire circuits for the diagrams from two and three-wire control circuits, jog circuits and hand-off-automatic (HOA) controls, timers and sequential controls, and speed controls.
