ECT 222 ADVANCED ELECTRICAL SYSTEM LEVEL 1

PREREQUISITE: None

COURSE DESCRIPTION

The selection, installation, operation and maintenance of generators, to include how to isolate and repair minor generator problems. Understanding of a battery or Uninterrupted Power Supply (UPS) and associated components.

1. <u>COURSE GOAL</u>

Develop the basic knowledge of NEC requirements for emergency/standby power and lighting systems.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Identify types of essential electrical circuits in healthcare facilities.
- 2.2 Describe receptacle requirements for hospital-grade Category 1 & Category 2 spaces.
- 2.3 Identify grounding requirements for fixed equipment.
- 2.4 Identify wiring requirements for inhalation, anesthetizing, x-ray, communication, signaling, data and fire alarm systems locations.
- 2.5 Identify emergency/standby power system components.
- 2.6 Explain the principles of transfer switch operation with respect to configuration and sizing.
- 2.7 Describe different types of batteries, maintenance requirements and charging specifications.
- 2.8 Describe legally required standby systems, as well as alternate power requirements for healthcare facilities and place of assembly.
- 2.9 Describe emergency lighting requirements for public buildings.
- 2.10 Explain basic electronic theory and semiconductor fundamentals.
- 2.11 Describe the operation and use of diodes, transistors and semiconductor switching devices.
- 2.12 Explain how codes and standards are implemented using the NFPA system.
- 2.13 Describe the basic types of fire alarm systems and control panels with respect to various codes and standards.
- 2.14 Identify various type of transformers
- 2.15 Explain the effects of harmonics in office buildings and industrial plants, as well as how to resolve issued related to harmonics
