COURSE DESCRIPTION

The selection, installation and termination of medium voltage cabling. Requirements of testing medium voltage cable.

1. <u>COURSE GOALS</u>

Develop the basic knowledge of medium-voltage cables.

- 2.2 Identify termination classes and stress-control methods for medium-voltage cable.

- 2.4 Identify and select equipment, components and wiring methods for various special locations and applications.
- 2.5 Describe current issues and organizational structure in today's industry including gender and cultural issues.
- 2.6 Explain how to incorporate leadership skills into work habits, including communications, motivation, team-building, problem-solving, and decision-making skills.
- 2.7 Explain the purpose of OSHA and describe its role in administering worker safety.
- 2.8 Demonstrate a basic understanding of the planning/scheduling process and resource control.
