ECT 230 PROGRAMMABLE LOGIC CONTROLLERS

PREREQUISITE: ECT 210

COURSE DESCRIPTION

Introduction to programmable logic controllers (PLC) architecture and programming. Topics include: memory, instruction sets, addressing modes, serial/parallel interfacing, relay/ladder logic, and troubleshooting.

Provide the students the understanding of PLC applications in the electrical industry.

Upon satisfactory completion of this course, students will be able to:

- 2.1 Identify and explain the function of each block within PLC architecture and describe memory of a PLC.
- 2.2 Describe the PLC instruction set including addressing modes and write debug programs for a PLC.
- 2.3 Identify, explain and draw ladder logic symbols and diagrams and utilize these to troubleshoot a PLC system.
