COURSE DESCRIPTION

The selection, installation, operation and maintenance of generators, to include how to isolate and repair minor generator problems.

1. **COURSE GOALS**

- 1.1 Develop the basic knowledge of generator operations.
- 1.2 Prepares learners to acquire the knowledge to troubleshoot generators.

- List and practice safety precautions related to generator operation/maintenance. 2.10
- 2.11 Display working knowledge of all codes related to generator installation/operation.

6. STUDENT RESPONSIBILITIES
