## EDU 201 ENGLISH GRAMMAR FOR TEACHERS

(Same as SLT 201)

Credit Hours: 3 Lec 3

PREREQUISITE: None

COURSE DESCRIPTION

Review of the form and use of English verb tenses and other key grammatical structures in order to equip teachers of all subject areas and levels with the knowledge and skills necessary to explain grammatical concepts to students, especially to non-native speakers of English.

1. COURSE GOAL

Further students' knowledge of English grammar through an intensive review of verb tenses and other key grammatical structures. Through analysis, practice, and discussion, students will explore not only the forms and uses of these structures, but also ways to help their own students avoid common mistakes in English.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate appropriate use of verb tenses (active and passive voice) and other grammatical structures such as definite and indefinite articles, subject and object pronouns, conditionals, and comparative and superlative forms of adjectives and adverbs.
- 2.2 explain the relationship between verb tenses and aspects: simple present vs. present progressive, simple past vs. past progressive, present perfect vs. present perfect progressive, past perfect vs. past perfect progressive, and future perfect vs. future perfect progressive.
- 2.3 explain the rules related to the spelling of plural nouns, the progressive form of verbs, past participles, and the comparative and superlative forms of adjectives and adverbs.
- 2.4 explain the use of auxiliaries and modals.
- 2.5 identify the patterns which dictate the use of gerunds and infinitives.
- 2.6 explain the use of possessive forms.
