EDU 210 CULTURAL DIVERSITY IN EDUCATION Credit Hours: <u>3</u> Lec <u>3</u>

PREREQUISITE: EDU 110

COURSE DESCRIPTION

This introductory course examines the relationship of cultural values to the formation of the child's self-concept and learning styles. Also incorporated will be an examination of the roles of prejudice, stereotyping and cultural incompatibilities in education. In addition to regular class attendance, ten (10) hours of classroom observation is required.

1. COURSE GOAL

Offer an equal education opportunity to children of all cultural groups.

Upon satisfactory completion of this course, students will be able to:

- 2.1 define the concept of multicultural education.
- 2.2 discuss concepts of stereotyping and discrimination.
- 2.3 discuss how groups experience stereotyping and discrimination.
- 2.4 relate personal impact of specific incidents of stereotyping and discrimination.
- 2.5 describe how the concepts of equity and equal educational opportunity have evolved into educational policy.
- 2.6 identify legal precedents for educational equity and equal education opportunities.
- 2.7 define and contrast different learning styles and teaching styles as it applies to multicultural education.
- 2.8 relate fictional literature for children to real educational situations.
- 2.9 implement strategies into lesson plans.
