EGR 253 MECHANICS OF MATERIALS

Credit Hours: 3 Lec 3

PREREQUISITE: EGR 251

COURSE DESCRIPTION

Basic concepts of solid mechanics; relationships between stresses, strains, deformations and internal forces in machine components and load-bearing structures.

1. COURSE GOAL

Develop understanding of force, stress, strength, load and resistance factor design, stress-strain diagrams, torsion in a circular shafts, shear and bending moment diagrams, flexure stress and design of beams, shear stress, transformation of stress, beam deflection, and columns design.

Upon satisfactory completion of this course, students will be able to:

- 2.1 use the method of sections to draw free body diagrams and subsequently determine external and internal forces using equilibrium principles and mathematical tools.
- 2.2 calculate stresses, strains and deformations in various machines and load-bearing structures subjected to axial force, torsion, shear, and bending actions.
- 2.3 design safe load-bearing components.
- 2.4 present engineering calculations in a clear, logical, and professional manner.
- 2.5 develop and demonstrate the behaviors of effective problem solving.
