# **COURSE DESCRIPTION**

This is the second of three modules designed to prepare the working EMT-B for certification as a Paramedic in the State of Arizona.

- 1.3 Introduce advanced intervention techniques.
- 1.4 Familiarize the student with assessment and management of patients with medical complaints.
- 1.5 Prepare the student for clinical and vehicular externships.

- 2.2 perform patient assessment to National Registry of Emergency Medical Technicians standards.

  - 2.3.3 Nervous system disorders.
  - 2.3.4 Endocrine disorders.
  - 2.3.5 Acute Abdomen.

  - 2.3.7 Toxicological disorders.
  - 2.3.8 Infectious diseases.
  - 2.3.9 Environmental disorders.
  - 2.3.10 Geriatric/Gerontologic disorders.
- 2.4 demonstrate correct EMS patient documentation to local standards.

### 6. STUDENT RESPONSIBILITIES
