## ENG 265 WOMEN WRITERS

Credit Hours: 3 Lec 3

General Education Course: WI (Writing Intensive)

H (Historical Awareness)

PREREQUISITE: ENG 101 or 107

THIS COURSE IS DESIGNATED AS WRITING INTENSIVE: Arizona Western College believes writing provides students a unique opportunity to learn disciplinary content while mastering writing skills. Writing-Intensive (WI) courses at Arizona Western College integrate writing assignments in ways that help students learn both the subject matter of the courses and discipline-specific ways of thinking and writing. Writing Intensive courses help develop students' identities as good writers by linking their writing proficiency with their desire to know more about the field of study, to engage in questions in the discipline, and to become a participant in academic discourse.

## COURSE DESCRIPTION

In this course, students will explore fiction, poetry, plays, and non-fiction written by women in English. Included in this exploration are the critical examination of the context in which women have written and continue to write, and the impact of that writing on the canonical tradition of literature. Essential to the course is writing that represents women's varied cultural, sexual, economic, ethnic, and racial experiences as they intertwine with gender to inform the identities of these women writers and their writing.

1. COURSE GOAL

This course is designed to help students develop an appreciation for diverse styles and forms used by women writers in various genres, their contributions to literature as a whole, and the critical approaches employed in reading and responding to women in literature.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify the aesthetic and substantive contributions of women writers to the field of literature and non-fiction.
- 2.2 interpret and analyze themes, imagery, and characterizations found in women's literature and non-fiction.
- 2.3 compare and contrast different works written by women exploring particular themes, imagery, and characterizations within and among those works.
- 2.4 research, evaluate, and synthesize literary criticism, biographical, and historical information written about the texts and writers considered.
- 2.5 identify the social and historical forces that have affected women's lives and their writing during various eras explored.
- 2.6 analyze how women writers employ the elements of fiction and non-fiction in order to explore, expose, and critique the social issues that revolve around gender, race, class, and spiritual orientation.

WI OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.7 Demonstrate critical inquiry through the gathering, interpretation, and evaluation of evidence in writing.
- 2.8 Develop flexible strategies for generating ideas, revising, editing, and proofreading, using instructor and peer feedback on written discourse to guide improvement through revision.
- 2.9 Effectively compose discipline-specific writing, which includes overall organization, analysis, grammar, mechanics, punctuation, and style.
- 2.10 Develop strategies for composing both in class and out of class compositions.
- 2.11 Demonstrate through written discourse a sequence of increasing complexity/skill in knowledge of content as well as discipline specific discourse form.

- 5.3 At least 33% of the student's grade in the course will be based on written discourse consisting of minimum of 3000 words or about 12 pages or revised writing.

## 7. STUDENT RESPONSIBILITIES
