EOT 100 - Energy Optimization Technology

Credit Hours: 4 Lec 3, Lab 2

PREREQUISITE: N/A

COURSE DESCRIPTION

This course introduces students to energy auditing principles and industrial assessments. The curriculum emphasizes energy usage analysis, energy efficiency and thermodynamics, and building airflow and weatherization for energy efficiency. It also explores integrating waste minimization and process optimization to transition from energy audits to industrial assessments.

1. COURSE GOAL

- 1.1. Demonstrate an understanding of energy auditing processes and methodologies through course curriculum, learning activities and evaluation criteria.
- 1.2. Analyze energy usage patterns and recommend optimization strategies.
- 1.3. Implement course concepts of energy conservation and thermodynamics to enhance energy efficiency.
- 1.4. Evaluate airflow and weatherization techniques in buildings by conducting assessments, identifying inefficiencies, and recommending improvements based on industry standards.
- 1.5. Differentiate between residential energy audits and industrial assessments by analyzing key differences, incorporating process improvement strategies, and applying waste minimization techniques in real-world scenarios.

- 2.1 Conduct energy audits for buildings.
- 2.2 Analyze and optimize energy usage using real-world data.
- 2.3 Apply energy conservation principles and models to improve energy efficiency of building systems.
- 2.4 Identify weatherization strategies to improve building energy performance.
- 2.5 Transition from traditional energy audits to industrial assessments.
