ARIZONA WESTERN COLLEGE SYLLABUS

FLR 102, FLOORING INSTALLATION TECHNICIAN - RESILIENT

Credit Hours: 2 Lec 1, Lab 2 PREREQUISITE: NONE

COURSE DESCRIPTION

This course introduces students to the types of flooring and installation procedures used in the resilient flooring processes. Topics covered include resilient flooring types, moisture identification, cutting, adhesives and grout, dead zone and floating floors, and measuring and estimating.

1. <u>COURSE GOAL</u> Provide instruction in the principles and practices of resilient flooring installation

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Identify proper techniques for resilient installation within standards
- 2.2 Demonstrate the use of Personal Protective Equipment (PPE) at all times
- 2.3 Demonstrate proper subfloor preparation and installation techniques
- 2.4 Employ appropriate techniques and use of tools to achieve a proper floating floor and dead zone flooring installation
- 2.5 Utilize proper finish carpentry methods
- 2.6 Implement standard procedures and tool use for mixing and applying grout and urethanes
- 2.7 Perform measuring and estimating procedures for resilient flooring installations

6. <u>STUDENT RESPONSIBILITIES</u>
