**HLS 220 BORDER SECURITY**

PREREQUISITE:

### **COURSE DESCRIPTION**

A comprehensive overview of border security, focusing on the strategic context and evolving challenges in managing borders. The course covers key concepts such as the flow of people, goods, money, and information across borders, and the impact of globalization on traditional border management paradigms.

### 1. COURSE GOAL

- 1.1 Describe the historical evolution of borders and their significance in modern geopolitics.
- 1.2 Analyze the various threats and challenges associated with border security, including illegal immigration, smuggling, and terrorism.
- 1.3 Examine the role of technology and international cooperation in enhancing border security.
- 1.4 Develop strategies for effective border management that balance security with the facilitation of legitimate trade and travel.

- 2.2 explain the historical relevance of border security

### 6. STUDENT RESPONSIBILITIES
