COURSE DESCRIPTION

MUS-111 Dictation and Sight Reading develops students' skills in aural perception and analysis, and in music reading and sight singing.

1. <u>COURSE GOAL</u>

- 1.1 Develop skills in sight singing.
- 1.2 Develop skills in sight singing by use of the movable Do system.
- 1.3 Develop the aural skills of hearing and notation of melodies.
- 1.4 Develop the aural skills of hearing and notation of harmonies; 2, 3 and 4 part.
- 1.5 Develop the aural skills of hearing and notation of rhythms in simple and compound meter.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Recognize and identify all note values and rests
- 2.2 Recognize and identify all meter signatures and terms for time and rhythm
- 2.3 Recognize and identify all major and minor keys
- 2.4 Recognize and identify all of the intervals within the octave
- 2.5 Recognize and identify all major, minor, diminished and augmented triads
- 2.6 Recognize and identify primary chords and common chord progressions in all major and minor keys
- 2.7 Recognize and identify diatonic melodies
- 2.8 Read and perform basic rhythmic patterns in simple and compound meter
- 2.9 Recognize and identify the division and sub-division of the beat
- 2.10 Read and sing the intervals within the octave

6. <u>STUDENT RESPONSIBILITIES</u>
