# ARIZONA WESTERN COLLEGE SYLLABUS

MUS 163E STRING INSTRUMENT - ELECTRIC BASS 1A

Credit Hours: 1\_Lec/Lab: .6

PREREQUISITE: Instructor permission required

#### **COURSE DESCRIPTION**

This is applied music, an individual half-hour per week lesson designed to develop college-level performing skills on the electric bass. This course is optional for music majors whose major instrument is the bass. This is the first semester of the class.

### 1. COURSE GOALS

- 1.1 Materials that fit the skill level of the student and address the needs for improvement will be selected.
- 1.2 Activities that improve note reading skills, correct posture, and correct hand position will be implemented.
- 1.3 An acceptable proficiency for end-of-the-semester performance will be attained.

## 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate clear and precise articulation.
- 2.2 demonstrate control and refined tone production over the range of the instrument.
- 2.3 demonstrate technical proficiency.
- 2.4 demonstrate technical flexibility.
- 2.5 demonstrate accurate intonation.
- 2.6 demonstrate a refined concept of musical interpretation.
- 2.7 read and correctly interpret the various chord symbol notations.

#### 3. <u>METHODS OF INSTRUCTION</u>

The course is a one-on-one private lesson.

#### 4. <u>LEARNING ACTIVITIES</u>

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

#### 5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
- 5.2 Please see the instructor's class schedule and assignment sheet for more information.

#### 6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
