MUS 166B STRING INSTRUMENT – VIOLA 1B

Credit Hours: 2 cr, 1.2 lec/lab

PREREQUISITE: MUS 163B or MUS 165B and instructor permission required

COURSE DESCRIPTION

This is applied music, an individual one-hour per week lesson designed to develop college-level performing skills on the viola. This course is required of music majors whose major instrument is the viola. This is the second semester of the class.

1. COURSE GOALS

- 1.1 Materials that fit the skill level of the student and address the needs for improvement will be selected.
- 1.2 Activities that improve note reading skills, correct posture, and correct hand position will be implemented.
- 1.3 An acceptable proficiency for end-of-the-semester performance will be attained.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate increasingly clear and precise articulation.
- 2.2 demonstrate control and increasingly refined tone production over the range of the instrument.
- 2.3 demonstrate increasing technical proficiency.
- 2.4 demonstrate increasing technical flexibility.
- 2.5 demonstrate increasingly accurate intonation.
- 2.6 demonstrate an increasingly refined concept of musical interpretation.

3. METHODS OF INSTRUCTION

The course is a one-on-one private lesson.

4. LEARNING ACTIVITIES

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.

4.3 Sight-reading exercises and duets will augment other study materials.

5. EVALUATION

5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.

6. STUDENT RESPONSIBILITIES
