MUS 166D STRING INSTRUMENT - STRING BASS 1B

Credit Hours: 2 cr, 1.2 lec/lab

PREREQUISITE: MUS 163D or MUS 165D and instructor permission required

COURSE DESCRIPTION

This is applied music, an individual one-hour per week lesson designed to develop college-level performing skills on the string bass (contrabass, double bass, acoustic bass). This course is required of music majors whose major instrument is the bass. This is the second semester of the class.

1. COURSE GOALS

- 1.1 Materials that fit the skill level of the student and address the needs for improvement will be selected.
- 1.2 Activities that improve note reading skills, correct posture, and correct hand position will be implemented.
- 1.3 An acceptable proficiency for end-of-the-semester performance will be attained.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate increasingly clear and precise articulation.
- 2.2 demonstrate control and increasingly refined tone production over the range of the instrument.
- 2.3 demonstrate increasing technical proficiency.
- 2.4 demonstrate increasing technical flexibility.
- 2.5 demonstrate increasingly accurate intonation.
- 2.6 demonstrate an increasingly refined concept of musical interpretation.

3. <u>METHODS OF INSTRUCTION</u>

The course is a one-on-one private lesson.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
- 5.2 Please see the instructor's class schedule and assignment sheet for more information.

6. <u>STUDENT RESPONSIBILITIES</u>
