ARIZONA WESTERN COLLEGE SYLLABUS

MUS 173C WOODWIND INSTRUMENT- CLARINET 1A

Credit Hours: 1 cr, .6 lec/lab

PREREQUISITE: instructor permission required

COURSE DESCRIPTION

This applied music, an individual half-hour per week lesson designed to develop college-level performing skills on the clarinet. This course is required of music majors whose major instrument is the clarinet. This is the first semester of the class.

1. COURSE GOAL

The lessons provide one-on-one instruction with the goal of improving a student's technical and musical skills.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 have a strong, secure embouchure.
- 2.2 have clear and precise articulation.
- 2.3 control and refine tone production over the range of the instrument.
- 2.4 have technical proficiency.
- 2.5 have flexibility.
- 2.6 have accurate intonation.
- 2.7 have a refined concept of musical interpretation.

3. METHODS OF INSTRUCTION

The course is a one-on-one private lesson.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

5. EVALUATION

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
