COREQUISITE: MUS 111

COURSE DESCRIPTION

The materials and structural elements of music -- pitch, rhythm, melody, tonality, harmony, and scale systems are the focus of this course. It is required for music majors and minors.

1. COURSE GOALS

- 1.2 Read and write rhythms in simple, compound and composite meter.
- 1.3 Construct and recognize intervals and their inversions.
- 1.4 Construct and recognize major and minor scales and key signatures.
- 1.5 Understand, recognize and construct phrases and cadences, and the historical period as it relates to melodic and harmonic construction.
- 1.6 Construct triads in root position, 1st inversion and second inversion.
- 1.7 Develop skills in 4 part voice leading and doubling techniques.
- 1.8 Transpose music for different instruments.
