COURSE DESCRIPTION

A continuation of MUS 191.

1. COURSE GOALS

- 1.1 Analyze and create harmonic progressions and cadences.
- 1.2 Correctly use the dominant 7th chord.
- 1.3 Recognize and use Non-harmonic tones.
- 1.4 Recognize, analyze, construct and utilize secondary dominant chords.
- 1.5 Understand and create elementary modulations by pivot chord.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Identify and construct harmonic progressions and cadences.
- 2.2 Identify and construct the dominant 7th chord.
- 2.3 Identify and construct non-harmonic tones.
- 2.4 Utilize secondary dominant chords.
- 2.5 Compose in 4 part writing using elementary modulations.

6. STUDENT RESPONSIBILITIES
