## MUS 208 CIVIC LIGHT ORCHESTRA

Credit Hours: 1 Lec 1 Lab 2

PREREQUISITE: MUS 118 and 16 years of age or over

COURSE DESCRIPTION

Intermediate level of Civic Light Orchestra.

1. COURSE GOAL

The Civic Light Orchestra performs light classical or popular music for major concerts. The orchestra also performs upon request for the college and other public functions

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 play and perform the finest light classical or popular orchestral literature at the sophomore level.
- 2.2 execute the basic components of playing – tone quality, balance, blend, intonation, technique, rhythm, and ensemble awareness – at the sophomore level.
- 2.3 sight-read music, possess good pitch, and understand the basics of melody, harmony, tonal balance, rhythm, bowing, technique, and ensemble skills at the sophomore level.
- 2.4 perform in public at the highest possible level.
- 2.5 demonstrate familiarity with musical terms.
- 2.6 demonstrate an understanding of orchestral protocol in rehearsals and performances.

3. METHODS OF INSTRUCTION

All instruction will follow standard rehearsal procedures

4. LEARNING ACTIVITIES

- 4.1 Rehearsal of music by the full ensemble and by section
- 4.2 Sight reading
- 4.3 Perfection of intonation across the orchestral ensemble
- 4.4 Perfection of technical playing across the orchestral ensemble
- 4.5 Perfection of ensemble playing and awareness
- 4.6 Awareness of orchestral protocol during rehearsals and performances

5. EVALUATION

- 5.1 Grades will be earned by an assortment of learning activities, performances, assignments, and participation

## 6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course.
