MUS 212 DICTATION AND SIGHT READING 2B

Credit Hours: 1 Lab 1

PREREQUISITE: MUS 211 COREQUISITE: MUS 292

COURSE DESCRIPTION

MUS 212 Dictation and Sight Reading 2B is a continuation of MUS 211.

1. COURSE GOAL

- 1.1 Develop skills in sight singing.
- 1.2 Develop skills in sight singing by use of the movable Do system.
- 1.3 Develop the aural skills of hearing and notation of melodies adding chromatic tones and modulation.
- 1.4 Develop the aural skills of hearing and notation of harmonies; 2, 3 and 4 parts, adding secondary dominants and other 7th chords.
- 1.5 Develop the aural skills of hearing and notation of rhythms in simple and compound meter using more and more complex rhythms including syncopation and mixed meter.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Know note values and rests.
- 2.2 Know meter signatures and mixed meter.
- 2.3 Continue use of all major and minor keys.
- 2.4 Know all of the intervals including compound.
- 2.5 Identification of all major, minor, diminished, augmented, 7th and secondary dominants and their use in 4 parts writing in all major and minor keys.
- 2.6 Dictate diatonic and chromatic melodies and harmonies.
- 2.7 Continue learning and reading more complex rhythmic patterns in simple and compound meter adding syncopation and compound meter.
- 2.8 Continue use of the division and sub-division of the beat.
- 2.9 Continue singing the intervals within the octave
