COURSE DESCRIPTION

Advanced level of Civic Orchestra.

1. <u>COURSE GOAL</u>

The Civic Orchestra performs music for full orchestra for major concerts. It performs upon request for the college and other public functions

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 play and perform orchestral literature in preparation for upper division study.
- 2.2 execute the basic components of playing tone quality, balance, blend, intonation, technique, rhythm, and ensemble awareness in preparation for upper division study.
- sight-read music, possess good pitch, and understand the basics of melody, harmony, tonal balance, rhythm, bowing, technique, and ensemble skills in preparation for upper division study.
- 2.4 demonstrate an understanding of orchestral protocol in performance.

3. <u>METHODS OF INSTRUCTION</u>

All instruction will follow standard rehearsal procedures

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Rehearsal of music by the full ensemble and by section
- 4.2 Sight reading
- 4.3 Perfection of intonation across the orchestral ensemble
- 4.4 Perfection of technical playing across the orchestral ensemble
- 4.5 Awareness of orchestral protocol during rehearsals and performances

6. STUDENT RESPONSIBILITIES
