COURSE DESCRIPTION

Advanced level of classical guitar ensemble performance at public events.

1. COURSE GOALS

- Develop an outstanding ensemble, skilled in performance techniques and capable 1.1 of a higher level of performance of guitar ensemble music
- Provide special opportunities for each individual, including solo opportunities and 1.2 select guitar literature for the highly qualified
- Provide an exciting and challenging musical experience for the performer and 1.3
- 1.4 Acquaint all participants with the potential for artistic performance
- 1.5 Attain maximum results in minimum time
- 1.6 Acquaint participants with classical guitar ensemble literature
- Develop sight reading skills at the level necessary to transfer 1.7

2. **OUTCOMES**

Upon satisfactory completion of this course, students will be able to:

- display a professional of mastery of classical guitar ensemble literature 2.1
- 2.2 display advanced musical precision in the guitar ensemble setting
- 2.3 perform public concerts
- demonstrate and display a higher level of artistic performance 2.4
- demonstrate the knowledge of classical guitar ensemble and solo literature 2.5 expected of a transfer student
- 2.6 demonstrate the ability to sight read at the sophomore level

3. METHODS OF INSTRUCTION

Instruction of the highly integrated skills, techniques and concepts of music will follow standard methods of rehearsal

- 4.2 New music will be studied and learned
- 4.3 Learned music will be rehearsed to improve artistic performance
- 4.4 Concepts and skills for artistic performance will be taught

- 6.5 Texts and Notebooks: Students are required to obtain the class materials for the course.
