ARIZONA WESTERN COLLEGE SYLLABUS

MUS 235 VOICE 2A Credit Hours: 2cr, 1.2 lec/lab

PREREQUISITE: MUS 134 or MUS 136 and instructor permission required

COURSE DESCRIPTION

Voice lessons are designed to serve the transfer music major with an emphasis in voice. Student and instructor meet for one-hour once per week to work on the advanced skills of singing and to build upon previous repertoire of music from generally the Baroque period to present. This course is required of music majors whose concentration is voice.

1. <u>COURSE GOALS</u>

- 1.1 Prepare the student for transfer to the university.
- 1.2 Teach the basic skills of breathing for singing, good posture, and technical facility.
- 1.3 Teach the etiquette of performing.
- 1.4 Teach the proper pronunciation of English.
- 1.5 Teach the proper pronunciation of and diction for Italian, French, German, and Spanish.
- 1.6 Build a basic repertoire of songs focusing on English, Italian, German, and French, because these are the languages in which the majority of arts songs (*Lieder*) and arias are written.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 perform solos in concert and in recital at the level of a college sophomore.
- 2.2 memorize 5 songs each semester to perform in a number of informal recitals and one formal recital at the level of a college sophomore.
- 2.3 demonstrate songs, scales, or other materials as directed by the instructor for the final exam (jury) to be heard in front of the music faculty at the level of a college sophomore.

3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Demonstration/Lecture (Lesson)
- 3.2 Working with accompaniment and accompanists
- 3.3 Listening to and, if appropriate, emulating recordings

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Stance, poise, and posture
- 4.2 Breathing and breath control
- 4.3 Diction and enunciation in English, Italian, French, German, and Spanish
- 4.4 Concert etiquette

5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
