# ARIZONA WESTERN COLLEGE SYLLABUS

MUS 244C BRASS INSTRUMENT- TROMBONE 2B

Credit Hours: 1 cr, .6 lec/lab

PREREQUISITE: MUS 243C or MUS 245C and instructor permission required

# **COURSE DESCRIPTION**

This is applied music, an individual half-hour per week lesson designed to develop college-level performing skills on the trombone. This course is required of music majors whose major instrument is the trombone.

#### 1. COURSE GOAL

The lessons provide one-on-one instruction with the goal of improving a student's technical and musical skills.

# 2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate a strong, secure embouchure in preparation for upper division study.
- 2.2 demonstrate clear and precise articulation in preparation for upper division study.
- 2.3 control and refine tone production over a professional-level range of the instrument.
- 2.4 demonstrate technical proficiency in preparation for upper division study.
- 2.5 demonstrate flexibility in preparation for upper division study.
- 2.6 demonstrate accurate intonation in preparation for upper division study.
- 2.7 demonstrate a refined concept of musical interpretation in preparation for upper division study.

#### 3. METHODS OF INSTRUCTION

The course is a one-on-one private lesson.

### 4. <u>LEARNING ACTIVITIES</u>

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

# 5. EVALUATION

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
