MUS 264G STRING INSTRUMENT - ELECTRIC GUITAR 2B

Credit Hours: 1 Lec/Lab: .6

PREREQUISITE: MUS 263G or MUS 265G – or instructor approval

COURSE DESCRIPTION

This is applied music, an individual half-hour per week lesson designed to develop college-level performing skills on the electric guitar. This course is optional for music majors whose major instrument is the guitar. This is the fourth semester of the class.

1. COURSE GOALS

- 1.1 Materials that fit the skill level of the student and address the needs for improvement will be selected.
- 1.2 Activities that improve note reading skills, correct posture, and correct hand position will be implemented.
- 1.3 An acceptable proficiency for end-of-the-semester performance will be attained.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 have clear and precise articulation in preparation for upper division study.
- 2.2 have control and refined tone production over the complete range of the instrument.
- 2.3 have technical proficiency in preparation for upper division study.
- 2.4 have technical flexibility in preparation for upper division study.
- 2.5 have accurate intonation in preparation for upper division study.
- 2.6 have a refined concept of musical interpretation in preparation for upper division study.
- 2.7 read and correctly interpret the various chord symbol notations.

3. METHODS OF INSTRUCTION

The course is a one-on-one private lesson.

4. LEARNING ACTIVITIES

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

5. EVALUATION

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.

6. STUDENT RESPONSIBILITIES
