MUS 266D STRING INSTRUMENT - STRING BASS 2B

Credit Hours: 2 cr, 1.2 lec/lab

PREREQUISITE: MUS 263D or MUS 265D and instructor permission required

COURSE DESCRIPTION

This is applied music, an individual one-hour per week lesson designed to develop college-level performing skills on the string bass (contrabass, double bass, acoustic bass). This course is required of music majors whose major instrument is the bass. This is the fourth semester of the class.

1. COURSE GOALS

- 1.1 Materials that fit the skill level of the student and address the needs for improvement will be selected.
- 1.2 Activities that improve note reading skills, correct posture, and correct hand position will be implemented.
- 1.3 An acceptable proficiency for end-of-the-semester performance will be attained.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate clear and precise articulation in preparation for upper division study.
- 2.2 demonstrate control and refined tone production over the complete range of the instrument.
- 2.3 demonstrate technical proficiency in preparation for upper division study.
- 2.4 demonstrate technical flexibility in preparation for upper division study.
- 2.5 demonstrate accurate intonation in preparation for upper division study.
- 2.6 demonstrate a refined concept of musical interpretation in preparation for upper division study.

3. METHODS OF INSTRUCTION

The course is a one-on-one private lesson.

4. LEARNING ACTIVITIES

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
- 5.2 Please see the instructor's class schedule and assignment sheet for more information.

6. <u>STUDENT RESPONSIBILITIES</u>
