ARIZONA WESTERN COLLEGE SYLLABUS

MUS 284 PERCUSSION 2B Credit Hours: 1cr, .6 lec/lab

PREREQUISITE: MUS 283 or MUS 285 and instructor permission required

COURSE DESCRIPTION

These are applied music, an individual half-hour per week lesson designed to develop college-level performing skills on percussion instruments. This course is required of music majors whose major instruments are the drums and other percussion.

1. COURSE GOAL

The aim of individual lessons, providing one-on-one instruction, is to improve a student's musical skills and prepare them for transferring to a four-year program

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will:

- 2.1 demonstrate proper techniques and rudiments (e.g., grip, stroke type) and other essential elements on all concert percussion and mallet/keyboard-type percussion in preparation for upper division study.
- 2.2 demonstrate proper tuning practices and basic maintenance on timpani and other pitched percussion in preparation for upper division study.
- 2.3 demonstrate control, refined tone production, and phrasing ability over the complete range of mallet/keyboard-type percussion in preparation for upper division study.
- 2.4 demonstrate proficiency on ethnic percussion instruments in preparation for upper division study.
- 2.5 demonstrate sophisticated knowledge of and the ability to perform basic styles like rock, swing, ballad, and Latin on the drum set in preparation for upper division study.
- 2.6 demonstrate proper techniques with sticks, brushes, and mallets over the entire spectrum of styles and instruments in preparation for upper division study.
- 2.7 demonstrate basic maintenance, phrasing, and sight reading skills and the drum set in preparation for upper division study.
- 2.8 describe their knowledge of and about the entire percussion family in preparation for upper division study.

3. <u>METHODS OF INSTRUCTION</u>

The course is a one-on-one private lesson.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 An individual lesson will be provided each week of the semester.
- 4.2 Scales, etudes, solos, and method books will be used for instruction.
- 4.3 Sight-reading exercises and duets will augment other study materials.

5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
- 5.2 Please see the instructor's class schedule and assignment sheet for more information.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be

the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course will be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
