MUS 70B CHAMBER SINGERS Credit Hours: <u>0.5</u> Lec <u>0</u> Lab <u>.5</u>

PREREQUISITE: None

COURSE DESCRIPTION

This vocal ensemble is dedicated to the performance of madrigals and other literature written for small choirs and chamber vocal ensembles. The class is designed for community members, high school students, and other performers. A multi-level class. CR/NC OE/OE

1. <u>COURSE GOALS</u>

- 1.1 The Chamber Singers will perform choral music for small ensembles for two major concerts per semester.
- 1.2 The choir may also sing for special concerts or social functions upon request.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate basic knowledge of music fundamentals.
- 2.2 perform the basics of singing: matching pitch, intonation, tone, blend, balance, enunciation, and pronunciation in English and several foreign language of music.
- 2.3 demonstrate a basic level of technical proficiency in preparation for public ensemble performance.

3. METHODS OF INSTRUCTION

All instruction will follow standard rehearsal procedures.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Rehearsal by full choir and by section
- 4.2 Sight reading of new music
- 4.3 Singing with good choral ensemble sound
- 4.4 Singing with good choral ensemble balance
- 4.5 Singing with good choral ensemble blend
- 4.6 Singing with clarity of pronunciation through vowel position and placement
- 4.7 It will be between the instructor and the student to determine how the class time during the semester.

5. <u>EVALUATION</u>

- 5.1 Grades will be earned by an assortment of learning activities, exams, assignments, and participation.
- 5.2 Please see the instructor's class schedule and assignment sheet for more information.

6. STUDENT RESPONSIBILITIES
